Updates to Health Net's 2016 Medicare Advantage Plan Codes by County

As a follow-up to provider update 15-592, *2016 Health Net Medicare Advantage Information*, distributed November 17, 2015, Health Net of Arizona, Inc. (Health Net) has updated the 2016 Medicare Advantage Plan Availability and Codes to include the Centers for Medicare & Medicaid Services (CMS) contract identification (ID) numbers and plan codes for 2015.
